## **Opening Remarks**

The meeting was opened at 4:00 pm EDT. Jack Glass introduced himself along with Vice Chair, David Quirk.

Jack reviewed the dates of the Winter meeting in Chicago from January 21 to 25 at the Palmer House Hilton. He noted the Technical Program is now available on the ASHRAE site. The times of the TC 9.9 meetings are Sunday at 5 pm and Monday at 2:15 pm.

Topics for the Committee meeting in Chicago were reviewed. Time will be allocated for the revised Thermal Guidelines, the new Water Cooling Guidelines, SSPC 90.1 issues and discussions of future Program topics. In addition, other agenda items will include SPC 127, SPC 189, current data center trends, PUE definitions, NFPA data center issues and an update on industry corrosion surveys.

## **Agenda:**

### **Programs Subcommittee – Nick Gangemi, Chair**

Nick stated that (2) Conference Papers and (2) Seminars are on the agenda for Chicago. Nick reviewed key dates for Chicago and San Antonio. Dates for submissions for both conferences are posted on the TC 9.9 Website.

### **Research Subcommittee – Mike Patterson, Chair**

Mike reported that the Humidity and ESD research study (1499) did not proceed due to disagreement over contract terms. It could be rebid in the Spring of 2012.

The research project 1487, Fluid Dynamics for rack-level cooling, should be ready for review and approval by TC 9.9 before the Winter meeting.

A survey will be sent to the TC members for their input regarding research topic priority.

### **Handbook Subcommittee – Chris Kurkjian, Chair**

It was reported that the editable version of the handbook chapter was available and downloaded from the ASHRAE site.

Members of the IT Subcommittee were requested to assist in updating the chapter with the most current information from the Power Trends book.

### **Standards Subcommittee - 90.1- Rick Pavlak, Chair**

Rick reported that there are 5 or 6 CMP's under review related to data centers. These will be reviewed with the TC 9.9 membership in Chicago.

Rick reported that the 90.1 / TC 9.9 Working Group continues to hold regular conference calls.

#### **IT Subcommittee – Roger Schmidt, Chair**

- The revised Power Trends book was sent out for review and approval by the Voting members. Comments received are under review for inclusion in the book.
- The Thermal Guidelines book will be revised next to include the new information about the air and liquid temperature ranges described in the new White Papers.
- A new White Paper about IT Equipment Thermal Control is in progress
- Members of the IT Subcommittee have been engaged with the European Code of Conduct group to align their recommendations with the ASHRAE guidelines. This will minimize confusion in the industry.

#### **Publications Subcommittee – Don Beaty, Chair**

- It was reported that preparations are being made for the revisions to the two books mentioned above.

#### **SPC – 127 - Fred Stack**

No update was available for SPC 127

#### **Website Update – Ecton English, Webmaster**

- It was reported that we now have the ability to track the number of visitors to our site and the number of White Paper downloads.
- The ability to search the TC 9.9 site is now available.
- Content updates were requested of the Subcommittee Chairs.
